My Lived Experience/Background

- Diagnosed with Autism Spectrum Disorder (ASD) at the age of 2
- ❖ After getting diagnosed, my mom advocated for my brother and I to get the DD Waiver
- When we got the DD Waiver, we got early intervention
- When Mi Via was first launched, we switched over to Mi Via
- With Mi Via, we received special education services while in public schools and charter schools we attended
- Advocating for myself ever since high school



How I came up with my question for Problem-Framing

- We requested art lessons through Mi Via
- Art lessons did get approved by a Third-Party Assessor in 2018
- ❖ In 2019, my art lesson request was rejected by a Third-Party Assessor
- The Third-Party Assessor said it would not benefit me after my Mi Via consultant put in the same reasonings both years I requested art lessons.
- My question was how does Third-Party Assessors make decisions for Mi Via Services?



What is Mi Via?

- Mi Via is my way which means families/participants get to work with who they would feel most comfortable with
- Self-directed home and community based service
- Opportunity for others with disabilities to participate in services



What can someone do to gain eligibility for Mi Via Services?

- Meet the definition of IDD (Intellectual Developmental and Disabilities)
- Application process
- Contact DDSD (Development Disability Support Division)
- Has to meet financial eligibility and medical eligibility



What is the criteria to receive Mi Via Services?

- Anyone born with Development Disabilities, Intellectual Disability, IDD
- IQ level less than 70
- Functional limitations such as life skill areas and physical impairment
- Have a disability before turning 22
- Adaptive behaviors



Types of Adaptive Behaviors

- Language
- Self Care
- Cannot live on their own
- Cannot manage their own finance
- Has a learning disability



Product

- For my research, I read the Mi Via Advisory Committee (MVAC) Recommendations for the New Mexico Administrative Code
- ❖ I attended 2 Mi Via Advisory Committee (MVAC) Meetings for my research to learn more about Mi Via Services and how the Mi Via budget works
- ❖ After the meetings, I interviewed Chinda Lucoski from the Mi Via Advisory Committee and Jennifer Rodriguez from the New Mexico Developmental Disabilities Supports Division for this project.

Opportunity for others to participate in services, and does honor the person's needs

We chose Mi Via because of independent decisions who we hire, we get to chose who we get to have around to work with us and which locations we get services from.



How Mi Via Services get Approved by Assessors

Review all of the budgets we request

Service and Support Plan (SSP) reviews goals on what supports I will get that year.

Third Party Assessors (TPA) reviews everything then report back to the Employer of Record (EOR)

What is next?

- Keep records for services, educational and medical records to be approved for services.
- Have important documents as much as possible, parents goes to school to get the IEPs for appeals (before they leave school)

What happens when a previous service is denied by an assessor?

- · A person can request a fair hearing
- Allow them to argue the denial and justify why the person needs a service
- Administrative Law Judge through the H uman Services
 D epartment

How does Mi Via decide which agencies to work with as Third-Party Assessors?

Mi Via participant and families make the choices

The biggest direction of Mi Viais self-direction

Mi Via Budget

- Under 21, based budget is \$54,589
- Under 18, \$23,443
- Over 21 is \$72,710
- Additional funding for job coach

What essential needs are provided through the Mi Via Wavier?

- Day services
- Therapies such as Speech and Language Pathology (SLP) Occupational Therapy (OT), Physical Therapy (PT), behavioral therapy, and nursing)
- Massage therapy
- Environmental modifications (wheelchair to have ram built)
- Related good and services (helps with a gym membership, computer, phone)





Dissemination

- Dropping off brochures in various places such as the
 - CDD
 - New Mexico Developmental Disabilities Council
 - Parents Reaching Out (PRO)
 - The Arc of New Mexico
 - Education for Parents of Indian Children with Special Needs (EPICS)
- Call the agencies about a good time to drop the brochures off
- Email families who are interested
- Presenting the project when opportunity comes

- Educating others more about Mi Via
